## Global Chair Lee Denlinger to Step Down after Ten Years at the Helm



Next June 2020, at the RI Convention in Honolulu, Hawaii, Lee Denlinger will step down as Global Chair of our music Fellowship. During her tenure, the Fellowship membership has expanded to 44 countries, the Rotary World Choir has become a hallmark performing group, and the Board of Directors has grown from seven to 19 members. "More importantly," Lee will tell you, "I have undergone a personal transformation from viewing Fellowships as 'another group to join' to realizing that they bring Rotarians together based on interests and talents—what an excellent retention tool for Rotary!"

"The first RI Convention that I attended was held in Chicago, Illinois (USA) in 2005. With program booklet in hand, I went down the escalator in the Hall of Friendship to see what that was all about. I literally ran into the IFRM Booth where a group of Rotarians were singing. What fun! And that was the start of my journey into IFRM..."

Lee is no stranger to administration. After receiving her Master of Arts degree, she became the Deputy Director of the Peace Corps Training Center for Latin America in Albuquerque, New Mexico. She oversaw a multi-million dollar budget, coordinated program training activities for Peace Corps volunteers at two sites (Albuquerque and Taos, New Mexico), and developed innovative curriculum that responded to the skills volunteers would need.

In 1968, she opened a computer graphics business in Albuquerque and pioneered in the use of cold type to typeset manuscripts, books, and newspapers for local, state and national publishers.

A marriage and two childrren later led her to live in the Bay Area. Lee joined the American Association of University Women (AAUW) and within four years was on the AAUW State Board as the State Education Coordinator for 32,000 members. At the same time, Lee was a central office administrator and department chair in the Oakland Unified School District.

IFRM operates in accordance with Rotary International policy, but is not an agency of, nor controlled by, RI.

"My true love has always been teaching," states Lee. And that's exactly what Lee has been doing for 51 years, including a 7-year stint as professor in the Education Department at John F. Kennedy Univeristy in Pleasant Hill, California. "You learn something new every day," says Lee. "Teaching also keeps you connected with our changing world. It certainly also brings its own challenges...and I have learned patience," she quips.

Lee joined Rotary International in September 2004. Since she didn't know much about Rotary, she attended every available training session and volunteered where she could. "I naturally gravitated toward youth programs," Lee recalls. In 2008, District 5170 Governor Gary Citti asked her to be District Chair of Youth Service. "I was thrilled! I soon found out, however, that there was no such Avenue of Service as Youth Service." The rest is history....Lee wrote a proposal to create a Fifth Avenue of Service—Youth Service. The RI Legislative Assembly approved her proposal and the Rotary Constitution was changed to make Youth Service the Fifth Avenue of Service.

In 2009, Lee was elected President of the Rotary Club of Fremont, Union City and Newark Sunset. She successfully increased the membership from 7 to 15 members, put a leadership succession plan in place and developed a program of speakers that drew in the diverse community. "Most importantly," remembers Lee, "I worked with my club board to change our bylaws to recognize representatives from Interact and Rotaract as ad hoc members of our Board. We jointly developed our respective budgets, scheduled community activities, and mutually supported each others' fundraisers and programs."

Since 2010, Lee has served Rotary District 5170 in a variety of positions—District Chair of Vocational Service and Youth Service, District Chair of Global Networking Groups (Fellowships and Rotary Action Groups), and the District Chair of the Friendship Exchange Program. Lee is currently in her second term as an Assistant Governor in the District. At the club level, she has been President, Treasurer, Secretary, Trainer, and Youth Service Chair.

#### IFRM

In 2005, Susan DuPree followed PDG Chungsam Doh as IFRM Chair. Susan, a close friend, asked for Lee's help in sending out copies of *Music Notes* to the IFRM members. Lee worked closely with Susan that year and became the Editor of *Music Notes* in 2007. "I learned so much under Susan's tutelage," affirms Lee. "We spent endless hours talking about the best way to make IFRM a viable organization. It was during Susan's term that we computerized the database, developed the IFRM website and communicated by emails. Susan is very enthusiastic about all things musical—and is so good with relating to people. She is creative and not afraid to try new ways of doing things. Susan set the stage for how I administered IFRM during my term."

In 2010, Lee accepted the position as IFRM Global Chair. "I was prepared for a 5-year term," she recalls, "but here I am in my tenth year. No one



wanted to be Global Chair." At the last meeting of the Board of Directors, Lee announced that she was resigning as Global Chair in June 2020. "IFRM needs new blood," she declared. Fortunately, IFRM's longtime and current Treasurer, Rod Fivelstad, agreed to become Global Chair in July 2020. "I know that he will do a fabulous job and lead our Fellowship in new and exciting directions."

### Looking Ahead...

When Peter Drucker remarked, "The best way to predict the future is to create it," he could have had our music Fellowship in mind. Our organization has morphed over the years in structure, numbers and activities to become a leading RI Fellowship.

Since its inception in 1972, the International Fellowship of Rotarian Musicians has grown from a small group of male musicians (Rotary International didn't allow women in Rotary at that time) to a world-wide organization that claims active members on six continents and includes men and women, Rotarians, Rotaractors, and Rotary program alumni.

In keeping with a growing membership, the sevenmember Executive Committee expanded to today's 19-member Board of Directors. Vice-Chairs now respond to the administrative needs of its members. In utilizing technology, the database of members is now computerized, communication is through emails, social media sites, and dedicated IFRM mail lists. The single page news sheet that was composed on an Underwood typewriter, mimeographed, and sent through the mails in 1972 has been replaced by the internet publication of frequent e-bulletins (*Staccato*) and an annual newsletter, *Music Notes*. IFRM received "not for profit" status in July 1985 and was incorporated in California (USA) in 2004. In 2007, IFRM, Inc. was formed as a 501c3 Foundation in order to accept tax-deductible gifts in order to fund projects to promote music literacy throughout the world. Twelve "seed grants" have been awarded thus far to schools and community groups (see pp. 4-5 for a Summary of all IFRM grants to date).

In Rotary, members drop out when they find no value in belonging to an organization. Engagement and interaction with like-minded individuals keep our Fellowship viable. The members themselves determine what that means to them. In India, IFRMers organize themselves through their Rotary clubs and districts and provide entertainment in order to support district and club fundraising drives and programs. In England, IFRM helps to sponsor the Young Musicians Talent Competition. In many other areas, members promote singing in their Rotary clubs or gather in choirs.

In 1998, a small group of 12 IFRM members



called themselves the Rotary World Choir, gathering and singing at breakfasts and receptions at the RI Conventions. Today, this Rotary World Choir numbers over 100 IFRM singers and is the hallmark performing group of IFRM at RI Conventions.

What does the future of IFRM look like? It looks like singers, instrumentalists and lovers of music gathering together to sing, play and have fun. It looks like members composing musicals for local theater, members writing parodies for club members to enjoy, or talented members performing barbershop, singing arias in an opera, or singing the anthem at the opening of a sports event. IFRM looks like the many of us who have a smile on our face while we sing along at the IFRM Booth at the RI Convention. We are IFRM and the future is what we make it to be. Let's continue *Keeping the Beat!*

The **IFRM Foundation** (IFRM, Inc.) is a separate legal entity from our music Fellowship, but supports our mission by funding programs that promote indigenous music literacy.

# Summary of All IFRM Grants to Date Grenada

In 2004, Hurricanes Ivan and Emily damaged or destroyed over 90% of the buildings on the equatorial spice island of Grenada. One of the hardest hit buildings was St. Andrew's School. In addition to ripping off the school's roof, high winds and flooding destroyed the school's library and damaged its musical instruments.

**Peter Sotheran**, IFRM Membership Chair at the time, contacted the *IFRM Foundation* Trustees to see if they could help. Concurrently, he put out a call for donations of recorders through the local newspaper. The response was overwhelming. Thirty-eight recorders were donated, and IFRM granted monies to help re-establish St. Andrew's music program.

Sounds of steel pans now echo throughout St. Andrew's RC School in Grenada, West Indies, as students practice on the instruments funded by IFRM Foundation's supplemental grant to the school. The pans complete IFRM's mission to re-establish the music program that was devastated by two successive hurricanes in 2004.

#### New Orleans, LA, USA

Following the devastation of Hurricane Katrina in New Orleans, Louisiana, USA, an arts-centered school was founded for the students who had scattered throughout the region. IFRM Foundation linked with *Mr. Holland's Opus Foundation* to purchase sufficient instruments to establish a school band for the **McDonogh 15 School for the Creative Arts**. Realizing IFRM's mission statement "...to promote music through school and community projects," this project effectively established McDonogh's music program.

#### Manila, Philippines

IFRM partnered with the **Rotary Club of Manila 101** in a TRF Matching Grant. The IFRM grant funded CDs, musical instruments and music books for the mobile literacy van that served 3 to 5 year olds in the Manila area. This project grew out of Manila 101 RC's Day Care Nutritional Project for preschoolers. Realizing that these children did not have access to books to develop literacy skills, the RC members decided to raise funds for a traveling van. IFRM was invited to join in TRF Matching Grant so that the Fellowship could also provide the materials for music literacy.

#### **Bucharest**, Romania

In April, 2011, IFRM Music Director and IFRM Past Chair Susan DuPree had the unique opportunity to visit the Music Camp for Blind and Visually Impaired Children in Cluj, Romania. Their concert at the Biserica Reformata brought the audience to their feet as these children received a standing ovation. When Susan returned to the United States, she worked with the Rotary Club of Monterey Peninsula Sunrise (CA), the international cosponsor of an approved RI Matching Grant project hosted by the Rotary Club of Bucharest—The Old Court, to help fund a music camp in Bucharest, Romania from August 28 to September 3, 2011. IFRM Foundation was requested to join with the RC of Monterey Peninsula Sunrise; an IFRM grant was used to purchase four cellos and percussion instruments for this camp. At the conclusion of the music camp, the instruments remained in the Romanian office of Music Camp International for use by more children in subsequent camps.

#### Navajo Reservation, New Mexico

IFRM, through its Donor Advised Fund, linked with *Mr. Holland's Opus Foundation* (MHO) to purchase musical instruments for Ojo Amarillo Elementary, an underserved school on the Navajo

Reservation in New Mexico, USA. "When I received the call stating that Ojo was going to be a recipient of the Melody grant and a donation from the International Fellowship of Rotarian Musicians, I was so excited I did a little happy dance. These kids are going to be so excited! Right now I have kids sharing instruments and with this amazing donation they won't have to do that anymore," wrote the school's Music and Band Director, Sara Robb. IFRM's portion of the grant funded 5 clarinets, 2 bell and snare kits and 1 flute. *MHO* funded the rest, giving the school's band receiving a full set of instruments.

#### Kampala, Uganda

IFRM Foundation money kick-started their own efforts to raise funds to equip the Budo Junior School Band. The project was brought to our attention by **James Galabuzi**, the then IFRM Vice-Chair for Africa. The funds bought a set of acoustic instruments--guitars, brass and percussion--so that the pupils could make an immediate start on their music making.

#### Kilifi, Kenya

IFRM Foundation supported the Kilifi Harmonies, a community-based organization comprised currently of a group of 15 young men singing a capella. Members of St. Thomas Aquinas Church in Kilifi, where most of the members worship, requested musical instruments for the group. Musicians in the community pledged to teach music theory, voice and instrumental instruction to the growing number of youth interested in developing their musical skills. The IFRM Foundation Trustees saw this project as an opportunity to support a community-based request that offers a positive alternative program for youth and, at the same time, engages local musicians in a mentoring role with these young people. This is a community sustaining project which aims at bringing the youth together for a common goal in the community. It aims at using music to preach peace and empower the youth against social evils. The youth will perform songs during public celebrations and events. With a growing number of children interested in music, a supplemental grant to fund more instruments was granted in 2017.

# Grenada, W.I., Queen Elizabeth Home for Children

The major IFRM Foundation project in 2016 was to provide a basic set of musical instruments for a children's home on the Caribbean island of Grenada. The home caters to children aged from toddlers to mature teenagers. Most of the residents are orphaned and many of the others come from dysfunctional or abusive homes; consequently, many have minimal social skills. The management team at the Home intends to use music to help the youngsters to bond together, to develop their social skills and to learn to cooperate, rather than compete, to achieve an outcome. IFRM Foundation has provided a couple of guitars, a keyboard and a drum kit. A lecturer from nearby St. George's University has volunteered to teach a group of the residents to read music and to play the instruments.

# Henry County Middle School, McDonough, Georgia, USA

Henry County Middle School is located in McDonough, Georgia, an area outside Atlanta. In 2017, the IFRM Foundation linked with *Mr*. *Holland's Opus Foundation* grant and funded percussion instruments for the middle school band. This donation enabled more underserved youngsters to participate in the school's performing group.

#### Patty Wolfe Endowment Project (2019)

When Lifetime Member Patty Wolfe died, she left the IFRM Foundation an endowment in her name. These funds will be used in combination with other NGO grants to fund a one-week music workshop at Redcar and Cleveland College in Redcar, North Yorkshire, England for students 16+ to adult who have physical and learning disabilities. During one concentrated week students will draft, rehearse and present a short musical drama. The course will be led by two professional opera singers: Sarah Sweeting, who recently retired after a decade as the Principal Mezzo Soprano at the Sydney Opera House, and her musical partner, Eddie Muliau, a basso profundo, who is about to complete a season in Melbourne. This project will not only give students new experiences, but develop self-esteem through achieving a significant project. Patty Wolfe, who sang in musical theater, would be so proud!

News from Down Under

Greetings to all from Australia!

The music industry continues to thrive in our 'little' corner of the world. Since 2002, **Field Day** is the go-to event for fans of house, electronic, Indie and hip-hop music. This event attracts artists from all over the world as more than 20,000 people pile into The Domain every year. The recent line-up included Flume, George Maple, Baauer, Schoolboy Q and DJ Snake. Field Day is known as one of the friendliest music festivals in Sydney and is considered the best possible way to follow up the city's spectacular and world-famous New Year's Eve fireworks.

The inaugural **Sydney City Limits Festival** in 2018 was a massive hit. This one-day event caters to all ages and boasts an impressive line-up of newcomers and seasoned veterans. Centennial Parklands came alive to the strains of Vance Joy, The Libertines, Thundercat, Tash Sultana and the inimitable Grace Jones. Based on the massive Austin City Limits gig held in Texas (USA), the Sydney version was no less thrilling for those who attended. As well as the amazing artists, people enthused about the sense of community and the great food options that were offered.

Held for the first time in 2017, *Days Like This* quickly found its fans. Despite his advancing age, his baritone voice is still as powerful as ever. Patinkin's program included a variation of popular, classical and politically poignant songs. I was particularly impressed with his interpretation of Bohemian Rhapsody.

In August, I was honored to be invited to a performance by **Hugh Jackman**. He took the stage for an absolutely sensational spectacular at the Qudos Bank Arena in the Olympic Park complex here in Sydney. With a cast of what seemed to be thousands of dancers, Jackman was joined by the orchestra, the *Australian Children's Choir* (famous for our worldwide Qantas commercials) and even a group of five Aboriginal Australians--a wonderful tribute to our indigenous people. Joining him from the USA was the amazing **Keala Settle** who sang her world famous anthem from *The Greatest Showman* movie "This Is Me".

Jazz and Blues are available in abundance all over Australia, but in Sydney the most popular places are The Basement *(famous for many years)*, Sydney University, Foundry 616, Sound Lounge and Venue 505. So jazz is still alive and thriving! Come and check it out when you're in town!

The Sydney Opera House offers an extensive program of Opera and Classical Music at its many internal venues. Our theatres, which include The State, The Lyric, The Capitol, plus many suburban boutique venues, present all of the world's top shows. In fact, there is something musically to suit everyone, so wherever you are in the world if you're thinking of visiting us *downunder* you will most definitely not be starved for music.
